Market Report for Friday, 01 August 2025

DSE recorded a total turnover of TZS 20,121.99 million from 4,803,171 shares traded in 1,782 deals; and TZS 0.37 billion from bonds traded in 7 deals.

On the Block Trade Pre-arranged Market board, TBL counter traded a block of 2,000,000 shares. On the Normal Board, AFRIPRISE counter had 103,315 shares traded at a weighted average price of TZS 400 per share in 158 deals. CRDB counter had 2,606,425 shares traded at a weighted average price of TZS 1,130 per share in 1390 deals. DCB counter had 64,890 shares traded at a weighted average price of TZS 3,530 per share in 27 deals. MBP counter had 61 shares traded at a weighted average price of TZS 600 per share in 1 deals. MCB counter had 4,510 shares traded at a weighted average price of TZS 245 per share in 6 deals. MUCOBA counter had 20 shares traded at a weighted average price of TZS 400 per share in 2 deals. NICO counter had 5,948 shares traded at a weighted average price of TZS 1,640 per share in 42 deals. NMB counter had 13,510 shares traded at a weighted average price of TZS 7,425 per share in 52 deals. PAL counter had 60 shares traded at a weighted average price of TZS 260 per share in 2 deals. On the Government Bonds Board, a 20-year bond with a coupon rate of 15.25% and a face value of TZS 0.08 Bln was traded at a price of 105.2583% in 1 deals, a 20-year bond with a coupon rate of 15.49% and a face value of TZS 0.13 Bln was traded at prices of 104.0000%, 105.0000% and 117.7327% in 3 deals, a 25-year bond with a coupon rate of 15.75% and a face value of TZS 0.08 Bln was traded at a price of 118.0000% in 2 deals, while a 25-year bond with a coupon rate of 15.95% and a face value of TZS 0.05 Bln was traded at a price of 120.2040% in 1 deal.

On the Corporate Bonds Board, a 5-year bond with a coupon rate of 12.00% and a face value of TZS 10.00 Mln was traded at a price of 89.3000% in 1 deals
