Market Report for Thursday, 05 June 2025

DSE recorded a total turnover of TZS 3,872.03 Mln from 1,646,046 shares traded in 982 deals and TZS 117.45 Billion from bonds traded in 22 deals.

On the Block Trade Pre-aranged Market board, TBL counter traded a block of 416,980 shares. On the Normal Board, AFRIPRISE counter had 46,851 shares traded at a weighted average price of TZS 335 per share in 81 deals. CRDB counter had 1,098,353 shares traded at a weighted average price of TZS 790 per share in 710 deals. DCB counter had 15,415 shares traded at a weighted average price of TZS 140 per share in 35 deals. DSE counter had 465 shares traded at a weighted average price of TZS 3,250 per share in 5 deals. MBP counter had 89 shares traded at a weighted average price of TZS 480 per share in 6 deals. MCB counter had 617 shares traded at a weighted average price of TZS 280 per share in 10 deals. MKCB counter had 3,390 shares traded at a weighted average price of TZS 940 per share in 3 deals. MUCOBA counter had 10 shares traded at a weighted average price of TZS 400 per share in 1 deal. On the Government Bonds Board, a 2-year bond with a coupon rate of 12.50% and a face value of TZS 6.50 Bln was traded at a price of 105.0674% in 1 deal, a 10-year bond with a coupon rate of 11.44% and a face value of TZS 10.50 Bln was traded at a price of 100.3019% in 1 deal, a 10-year bond with a coupon rate of 14.00% and a face value of TZS 58.20 Bln was traded at a price of 99.7918% in 1 deal, a 15-year bond with a coupon rate of 13.50% and a face value of TZS 0.10 Bln was traded at prices of 92.1466% and 100.0000% in 2 deals, a 20-year bond with a coupon rate of 12.10% and a face value of TZS 0.15 Bln was traded at a price of 87.8861% in 1 deal, while a 20-year bond with a coupon rate of 15.49% and a face value of TZS 0.92 Bln was traded at prices of 100.0000%, 100.0001%, 108.0000%, 109.3066%, 110.0001% and 110.2440% in 7 deals. Also, a 25-year bond with a coupon rate of 15.75% and a face value of TZS 1.05 Bln was traded at prices of 111.0236%, 111.1557% and 113.2239% in 5 deals, while a 25-year bond with a coupon rate of 15.95% and a face value of TZS 30.04 Bln was traded at prices of 111.2914%, 111.9456% and 115.0000% in 4 deals.
