#### Market Report for Thursday, 08 May 2025

DSE recorded a total turnover of TZS 373.93 Mln from 336,022 shares traded in 724 deals, and TZS 5.64 Bln from bonds traded in 17 deals.

In the Normal Board, AFRIPRISE counter had 11,453 shares traded at weighted average price of TZS 265 per share in 97 deals. CRDB counter had 294,748 shares traded at weighted average price of TZS 800 per share in 433 deals. DCB counter had 606 shares traded at weighted average price of TZS 125 per share in 5 deals. DSE counter had 170 shares traded at weighted average price of TZS 2,600 per share in 5 deals. MBP counter had 940 shares traded at weighted average price of TZS 400 per share in 13 deals. MCB counter had 60 shares traded at weighted average price of TZS 290 per share in 2 deals. MKCB counter had 399 shares traded at weighted average price of TZS 600 per share in 4 deals. NICO counter had 4,131 shares traded at weighted average price of TZS 785 per share in 47 deals. NMB counter had 6,543 shares traded at a weighted average price of TZS 6,300 per share in 72 deals. On the Government Bonds Board, a 10-year bond with a coupon rate of 14.00% and a face value of TZS 1.00 Bln was traded at 104.6813% in 5 deals while a 15-year bond with a coupon rate of 13.50% and a face value of TZS 4.03 Bln was traded at 103.7179% in 1 deal. The market also traded a 20-year bond with a coupon rate of 15.25% and a face value of TZS 0.03 Bln at 109.9600% in 1 deal while a 20-year bond with a coupon rate of 15.49% and a face value of TZS 0.07 Bln was traded at prices of 107.6000%, and 110.1831% in 2 deals. Furthermore, a 25-year bond with a coupon rate of 12.56% and a face value of TZS 0.01 Bln was traded at 85.2403% in 2 deals while a 25-year bond with a coupon rate of 15.95% and a face value of TZS 0.28 Bln was traded at prices of 100.0000%, 106.7040%, 107.4190%, 108.9240% and 109.5000% in 6 deals.
