## Market Report for Friday, 09 May 2025

DSE recorded a total turnover of TZS 435.24 Mln from 226,071 shares traded in 726 deals, and TZS 10.90 Billion from bonds traded in 26 deals.

On the Block Trade Pre-arranged Market board, NMB counter traded a block of 34,000 shares. In the Normal Board, AFRIPRISE counter had 22,749 shares traded at weighted average price of TZS 265 per share in 70 deals. CRDB counter had 140,103 shares traded at weighted average price of TZS 790 per share in 491 deals. DCB counter had 2,160 shares traded at weighted average price of TZS 125 per share in 50 deals. MBP counter had 10 shares traded at weighted average price of TZS 440 per share in 1 deals. MCB counter had 120 shares traded at weighted average price of TZS 290 per share in 3 deals. MKCB counter had 6,784 shares traded at weighted average price of TZS 550 per share in 16 deals. MUCOBA counter had 20 shares traded at weighted average price of TZS 400 per share in 1 deal. NICO counter had 100 shares traded at weighted average price of TZS 790 per share in 6 deals. NMB counter had 1,060 shares traded at weighted average price of TZS 6,300 per share in 10 deals. On the Government Bonds Board, a 5-year bond with a coupon rate of 8.60% and a face value of TZS 6.80 Bln was traded at 99.4251% in 1 deal while a 10-year bond with a coupon rate of 14.00% and a face value of TZS 0.01 Bln was traded at 100.0001% in 1 deal. The market also traded a 20-year bond with a coupon rate of 15.25% and a face value of TZS 2.00 Bln at prices of 100.8544%, and 106.7083% in 2 deals while a 20-year bond with a coupon rate of 15.49% and a face value of TZS 0.26 Bln was traded at prices of 103.0000%, 103.9998%, 105.9998%, 106.0534%, and 108.2371% in 7 deals. Furthermore, a 25-year bond with a coupon rate of 15.75% and a face value of TZS 1.39 Bln was traded at prices of 108.0153%, 108.0154%, 108.0587%, 109.0154%, 110.0000%, and 110.0001% in 12 deals while a 25-year bond with a coupon rate of 15.95% and a face value of TZS 0.20 Bln was traded at prices of 100.0001%, 107.5459% and 108.9679% in 3 deals.

On the Corporate Bonds Board, a 5-year bond with a coupon rate of 10.25% and a face value of TZS 50.00 Mln was traded at 88.0000% in 1 deal, while a 5-year bond with a coupon rate of 12.00% and a face value of TZS 5.00 Mln was traded at 16.2700% in 1 deal.
