### Market Report for Friday, 11 July 2025

DSE recorded a total turnover of TZS 7,045.88 Mln from 2,849,054 shares traded in 1,976 deals, and TZS 12.21 Billion from bonds traded in 13 deals.

On the Block Trade Pre-arranged Market board, CRDB counter traded a block of 750,000 shares; TBL counter traded a block of 647,895 shares, while TPCC counter traded a block of 50,000 shares.
