Market Report for Monday, 12 May 2025

DSE recorded a total turnover of TZS 1,513.67 Mln from 582,831 shares traded in 1,181 deals, and TZS 18.10 Billion from bonds traded in 48 deals.

On the Block Trade Pre-arranged Market board, NMB counter traded a block of 200,000 shares. On the Normal Board, AFRIPRISE counter had 56,198 shares traded at a weighted average price of TZS 265 per share in 149 deals. CRDB counter had 260,420 shares traded at a weighted average price of TZS 790 per share in 704 deals. DCB counter had 45,597 shares traded at a weighted average price of TZS 125 per share in 159 deals. DSE counter had 109 shares traded at a weighted average price of TZS 2,700 per share in 7 deals. MBP counter had 60 shares traded at a weighted average price of TZS 420 per share in 4 deals. MKCB counter had 293 shares traded at a weighted average price of TZS 580 per share in 2 deals. NICO counter had 1,618 shares traded at a weighted average price of TZS 800 per share in 30 deals. NMB counter had 3,520 shares traded at a weighted average price of TZS 6,300 per share in 42 deals. On the Government Bonds Board, a 20-year bond with a coupon rate of 15.25% and a face value of TZS 10.85 Bln was traded at prices of 105.8521%, 106.7083%, 106.8328% and 109.0000% in 5 deals, a 20-year bond with a coupon rate of 15.49% and a face value of TZS 0.04 Bln was traded at prices of 102.0000% and 106.5200% in 2 deals, a 25-year bond with a coupon rate of 15.75% and a face value of TZS 5.95 Bln was traded at prices of 100.0000%, 100.0001%, 107.0000%, 108.0151%, 108.0153%, 108.5000%, 109.2000%, 109.5000%, 110.0000%, 111.0000% and 111.8227% in 35 deals, while a 25-year bond with a coupon rate of 15.95% and a face value of TZS 0.25 Bln was traded at prices of 106.8733% and 107.4190% in 6 deals.

On the Corporate Bonds Board, a 5-year bond with a coupon rate of 12.00% and a face value of TZS 50.00 Mln was traded at a price of 90.0000% in 1 deal.
