## Market Report for Tuesday, 13 May 2025

DSE recorded a total turnover of TZS 1,003.70 Mln from 439,748 shares traded in 802 deals, and TZS 17.19 Billion from bonds traded in 69 deals.

On the Block Trade Pre-arranged Market board, TCC counter traded a block of 100,000 shares. On the Normal Board, AFRIPRISE counter had 20,542 shares traded at a weighted average price of TZS 270 per share in 118 deals. CRDB counter had 174,130 shares traded at a weighted average price of TZS 790 per share in 445 deals. DCB counter had 17,230 shares traded at a weighted average price of TZS 130 per share in 55 deals. DSE counter had 27 shares traded at a weighted average price of TZS 2,700 per share in 2 deals. MBP counter had 338 shares traded at a weighted average price of TZS 440 per share in 7 deals. MCB counter had 50 shares traded at a weighted average price of TZS 290 per share in 4 deals. On the Government Bonds Board, a 15-year bond with a coupon rate of 13.50% and a face value of TZS 0.004 Bln was traded at prices of 102.7950% in 4 deals, a 15-year bond with a coupon rate of 14.50% and a face value of TZS 0.20 Bln was traded at a price of 102.4523% in 1 deals, a 20-year bond with a coupon rate of 15.25% and a face value of TZS 5.21 Bln was traded at prices of 106.2604%, 106.7083%, 106.9160%, 106.9875% and 107.2464% in 6 deals, a 20-year bond with a coupon rate of 15.49% and a face value of TZS 1.63 Bln was traded at prices of 100.0001%, 102.6000%, 103.6536%, 105.5904%, 106.5200%, 106.5874%, 107.9452%, 108.4061% and 111.7059% in 10 deals, while a 25-year bond with a coupon rate of 12.56% and a face value of TZS 0.04 Bln was traded at a price of 85.0000% in 1 deals. Also, a 25-year bond with a coupon rate of 15.75% and a face value of TZS 7.70 Bln was traded at prices of 99.7322%, 100.0000%, 104.0000%, 107.4350%, 108.0153%, 108.0154%, 108.0587%, 108.6151%, 109.0000%, 109.2142%, 110.0000%, 110.1035%, 110.6000%, 111.0000%, 111.5620%, 112.8793%, 113.1590%, 115.1381% and 115.1383% in 42 deals, while a 25-year bond with a coupon rate of 15.95% and a face value of TZS 1.01 Bln was traded at prices of 103.0769%, 105.0000%, 108.5885%, 108.6332% and 108.9566% in 5 deals. On the Corporate Bonds Board, a 3-year bond with a coupon rate of 9.50% and a face value of TZS 100.00 Mln was traded at a price of 100.0000% in 1 deal.
