Market Report for Monday, 14 July 2025

DSE recorded a total turnover of TZS 5,571.08 Mln from 3,145,735 shares traded in 2,010 deals, and TZS 16.81 Billion from bonds traded in 20 deals.

On the Block Trade Pre-arranged Market board, CRDB counter traded a block of 1,000,000 shares; NMB counter traded a block of 93,000 shares; TBL counter traded a block of 35,690 shares, while TPCC counter traded a block of 354,594 shares.

On the Normal Board, AFRIPRISE counter had 17,893 shares traded at a weighted average price of TZS 345 per share in 42 deals. CRDB counter had 1,211,134 shares traded at a weighted average price of TZS 1,000 per share in 1706 deals. DCB counter had 45,654 shares traded at a weighted average price of TZS 140 per share in 97 deals. KCB counter had 341,900 shares traded at a weighted average price of TZS 1,000 per share in 4 deals. MCB counter had 283 shares traded at a weighted average price of TZS 230 per share in 14 deals. MKCB counter had 386 shares traded at a weighted average price of TZS 1,300 per share in 2 deals. NICO counter had 4,758 shares traded at a weighted average price of TZS 1,200 per share in 28 deals. NMB counter had 116 shares traded at a weighted average price of TZS 7,100 per share in 4 deals. On the Government Bonds Board, a 10-year bond with a coupon rate of 11.44% and a face value of TZS 5.00 Bln was traded at a price of 96.8036% in 1 deal, a 20-year bond with a coupon rate of 15.25% and a face value of TZS 8.13 Bln was traded at a price of 109.5235% in 5 deals, a 20-year bond with a coupon rate of 15.49% and a face value of TZS 1.79 Bln was traded at prices of 100.0000%, 100.0001%, 101.50/6%, 103.0000%, 106.9860%, 107.4634%, 109.2858%, 109.5000% 109.9893%, 116.0001% and 118.0079% in 11 deals, a 25-year bond with a coupon rate of 15.75% and a face value of TZS 1.06 Bln was traded at prices of 100.0001% and 104.7679% in 2 deals, while a 25-year bond with a coupon rate of 15.95% and a face value of TZS 0.01 Bln was traded at a price of 115.0001% in 1 deal.

On the Corporate Bonds Board, a 3-year bond with a coupon rate of 9.50% and a face value of TZS 1.40 Mln was traded at a price of 89.0000% in 1 deal, while a 5-year bond with a coupon rate of 12.00% and a face value of TZS 1.00 Mln was traded at a price of 100.0000% in 1 deal.
