## Market Report for Friday, 16 May 2025

DSE recorded a total turnover of TZS 649.66 Mln from 692,079 shares traded in 868 deals, and TZS 42.88 Billion from bonds traded in 24 deals.

On the Block Trade Pre-arranged Market board, TCCL counter traded a block of 186,785 shares. On the Normal Board, AFRIPRISE counter had 162,868 shares traded at a weighted average price of TZS 295 per share in 149 deals. CRDB counter had 265,846 shares traded at a weighted average price of TZS 790 per share in 485 deals. DCB counter had 39,707 shares traded at a weighted average price of TZS 125 per share in 60 deals. DSE counter had 749 shares traded at a weighted average price of TZS 2,800 per share in 12 deals. MBP counter had 4,138 shares traded at a weighted average price of TZS 440 per share in 12 deals. MCB counter had 20 shares traded at a weighted average price of TZS 290 per share in 2 deals. On the Corporate Bonds Board, a 3-year bond with a coupon rate of 9.50% and a face value of TZS 25.00 Mln was traded at a price of 89.0000% in 1 deal, while a 5-year bond with a coupon rate of 12.00% and a face value of TZS 5.00 Mln was traded at a price of 90.0000% in 1 deal.
