## Market Report for Thursday, 17 July 2025

DSE recorded a total turnover of TZS 1,386.72 Mln from 566,142 shares traded in 679 deals, and TZS 7.09 Bln from bonds traded in 26 deals.

On the Block Trade Pre-arranged Market board, TBL counter traded 160,265 shares.

On the Normal Board, the AFRIPRISE counter had 780 shares traded at a weighted average price of TZS 365 per share in 10 deals. The CRDB counter had 356,669 shares traded at a weighted average price of TZS 1,000 per share in 449 deals. The DCB counter had 3,483 shares traded at a weighted average price of TZS 140 per share in 27 deals. DSE counter had 1 share traded at a weighted average price of TZS 3,300 per share in 1 deal. The MBP counter had 13,429 shares traded at a weighted average price of TZS 480 per share in 6 deals. The MCB counter had 550 shares traded at a weighted average price of TZS 230 per share in 6 deals. The MKCB counter had 570 shares traded at a weighted average price of TZS 1,300 per share in 5 deals. NICO counter had 12,015 shares traded at a weighted average price of TZS 1,460 per share in 39 deals. NMB counter had 4,393 shares traded at a weighted average price of TZS 7,315 per share in 45 deals. The PAL counter had 111 shares traded at a weighted average price of TZS 305 per share in 9 deals. SWIS counter had 29 shares traded at a weighted average price of TZS 1,500 per share in 2 deals. The TBL counter had 50 shares traded at a weighted average price of TZS 9,500 per share in 3 deals. The TCC counter had 63 shares traded at a weighted average price of TZS 15,380 per share in 1 deal. The TPCC counter had 378 shares traded at a weighted average price of TZS 6,100 per share in 14 deals. TTP counter had 10 shares traded at a weighted average price of TZS 135 per share in 1 deal. VODA counter had 13,346 shares traded at a weighted average price of TZS 520 per share in 60 deals.

On the Government Bonds Board, a 10-year bond with a coupon rate of 14.00% and a face value of TZS 1.07 Bln was traded at prices of 109.2609%, and 112.3000% in 3 deals while a 20-year bond with a coupon rate of 15.25% and a face value of TZS 0.21 Bln was traded at 113.0347% in 2 deals.

A 20-year bond with a coupon rate of 15.49% and a face value of TZS 0.36 Bln was traded at prices of 100.0001%, 111.6211%, and 114.5989% in 3 deals while a 25-year bond with a coupon rate of 12.56% and a face value of TZS 0.13 Bln was traded at prices of 86.2881%, 87.0000%, and 95.0001% in 3 deals. A 25-year bond with a coupon rate of 15.75% and a face value of TZS 3.09 Bln was traded at prices of 100.0000%, 100.9979%, 102.5877%, and 106.5994% in 9 deals while a 25-year bond with a coupon rate of 15.95% and a face value of TZS 1.70 Bln was traded at prices of 109.9884%, 115.0000%, 117.4908%, 118.0000%, 122.2875% and 122.6758% in 6 deals.

On Corporate Bonds Board, a 5-year bond with a coupon rate of 10.00% and a face value of TZS 26.00 mln was traded at prices of 80.0000%, and 90.0000% in 2 deals while a 5-year bond with a coupon rate of 10.25% and a face value of TZS 28.00 Mln was traded at 78.5714% in 1 deal.
