#### Market Report for Tuesday, 17 June 2025

DSE recorded a total turnover of TZS 1,726.09 Mln from 2,854,098 shares traded in 1,134 deals, and TZS 26.54 Billion from bonds traded in 28 deals.

On the Block Trade Pre-arranged Market board, VODA counter traded a block of 1,786,530 shares. On the Normal Board, AFRIPRISE counter had 38,962 shares traded at a weighted average price of TZS 340 per share in 146 deals. CRDB counter had 462,995 shares traded at a weighted average price of TZS 790 per share in 558 deals. DCB counter had 6,038 shares traded at a weighted average price of TZS 140 per share in 14 deals. DSE counter had 1,225 shares traded at a weighted average price of TZS 2,760 per share in 11 deals. MBP counter had 470 shares traded at a weighted average price of TZS 515 per share in 5 deals. On the Corporate Bonds Board, a 5-year bond with a coupon rate of 12.00% and a face value of TZS 79.67 Mln was traded at a price of 99.8869% in 2 deals.
