Market Report for Wednesday, 18 June 2025

DSE recorded a total turnover of TZS 1,340.05 Mln from 1,726,141 shares traded in 916 deals, and TZS 26.57 Billion from bonds traded in 12 deals.

On the Block Trade Pre-arranged Market board, CRDB counter traded a block of 1,000,000 shares. On the Normal Board, AFRIPRISE counter had 23,035 shares traded at a weighted average price of TZS 340 per share in 92 deals. CRDB counter had 641,265 shares traded at a weighted average price of TZS 790 per share in 628 deals. DCB counter had 7,188 shares traded at a weighted average price of TZS 140 per share in 35 deals. DSE counter had 328 shares traded at a weighted average price of TZS 2,780 per share in 10 deals. MBP counter had 847 shares traded at a weighted average price of TZS 490 per share in 25 deals.
