Market Report for Thursday, 26 June 2025

DSE recorded a total turnover of TZS 990.39 Mln from 1,048,225 shares traded in 730 deals, and TZS 21.16 billion from bonds traded in 24 deals. In the Normal Board, AFRIPRISE counter had 16,948 shares traded at a weighted average price of TZS 340 per share in 83 deals. CRDB counter had 928,667 shares traded at a weighted average price of TZS 790 per share in 482 deals. DCB counter had 6,356 shares traded at a weighted average price of TZS 135 per share in 48 deals. DSE counter had 406 shares traded at a weighted average price of TZS 2,800 per share in 17 deals. MCB counter had 100 shares traded at a weighted average price of TZS 240 per share in 1 deals. MKCB counter had 134 shares traded at a weighted average price of TZS 1,040 per share in 2 deals. NICO counter had 33,614 shares traded at a weighted average price of TZS 920 per share in 25 deals. NMB counter had 29,420 shares traded at a weighted average price of TZS 6,650 per share in 16 deals. PAL counter had 90 shares traded at a weighted average price of TZS 310 per share in 3 deals. On the Government Bonds Board, a 15-year bond with a coupon rate of 11.15% and a face value of TZS 0.02 Bln was traded at 79.4223% in 1 deal while a 15-year bond with a coupon rate of 13.50% and a face value of TZS 0.03 Bln was traded at 92.9166% in 1 deal. The market also traded a 20-year bond with a coupon rate of 12.10% and a face value of TZS 0.04 Bln at 82.2503% in 1 deal while a 20-year bond with a coupon rate of 15.25% and a face value of TZS 3.86 Bln was traded at prices of 100.0000%, 110.2301%, 110.3443%, 111.1101%, and 111.6604% in 9 deals. Also, a 20-year bond with a coupon rate of 15.49% and a face value of TZS 9.07 Bln was traded at prices of 106.6389%, 109.7944%, 112.0000%, and 120.1895% in 4 deals while a 25-year bond with a coupon rate of 12.56% and a face value of TZS 0.02 Bln was traded at 99.0000% in 1 deal. Furthermore, a 25-year bond with a coupon rate of 15.75% and a face value of TZS 4.62 Bln was traded at prices of 102.8805%, 112.5411%, 116.3200%, and 117.0271% in 5 deals while a 25-year bond with a coupon rate of 15.95% and a face value of TZS 0.10 Bln was traded at prices of 107.4312% and 107.5000% in 2 deals.

On Corporate Bonds Board, a 3-year bond with a coupon rate of 9.50% and a face value of TZS 20.00 Mln was traded at prices of 89.0000%, and 91.1654% in 2 deals while a 5-year bond with a coupon rate of 10.00% and a face value of TZS 30.00 Mln was traded at 90.0000% in 1 deal. The market also traded a 5-year bond with a coupon rate of 12.00% and a face value of TZS 14.00 Mln, which was traded at 100.0000% in 4 deals.
