Market Report for Wednesday, 28 May 2025

DSE recorded a total turnover of TZS 444.92 Mln from 505,592 shares traded in 920 deals, and TZS 45.93 Billion from bonds traded in 17 deals. On the Normal Board, AFRIPIRISE counter had 36,093 shares traded at a weighted average price of TZS 300 per share in 114 deals. CRDB counter had 427,986 shares traded at a weighted average price of TZS 790 per share in 576 deals. DCB counter had 3,263 shares traded at a weighted average price of TZS 130 per share in 43 deals. DSE counter had 1,009 shares traded at a weighted average price of TZS 3,500 per share in 35 deals. MBP counter had 2,924 shares traded at a weighted average price of TZS 455 per share in 11 deals. MCB counter had 2,520 shares traded at a weighted average price of TZS 290 per share in 4 deals. MKCB counter had 2,010 shares traded at a weighted average price of TZS 760 per share in 12 deals. On the Government Bonds Board, a 5-year bond with a coupon rate of 13.00% and a face value of TZS 13.90 Bln was traded at a price of 103.4665% in 2 deals, a 15-year bond with a coupon rate of 13.50% and a face value of TZS 16.30 Bln was traded at prices of 101.8530%, 104.2283%, 108.2510% and 108.2922% in 4 deals, a 20-year bond with a coupon rate of 15.25% and a face value of TZS 1.60 Bln was traded at a price of 113.5962% in 1 deal, a 20-year bond with a coupon rate of 15.49% and a face value of TZS 0.70 Bln was traded at prices of 103.0001% and 104.5774% in 2 deals, a 25-year bond with a coupon rate of 15.75% and a face value of TZS 0.09 Bln was traded at prices of 108.0153%, 109.0000% and 113.5787% in 5 deals, while a 25-year bond with a coupon rate of 15.95% and a face value of TZS 10.14 Bln was traded at prices of 108.9989%, 109.2913% and 117.7926% in 3 deals.

On the Corporate Bonds Board, a 5-year bond with a coupon rate of 12.00% and a face value of TZS 44.83 Mln was traded at a price of 100.0000% in 4 deals.
