## Market Report for Thursday, 29 May 2025

DSE recorded a total turnover of TZS 816.27 Mln from 592,440 shares traded in 976 deals, and TZS 5.95 Billion from bonds traded in 23 deals. On the Block Trade Pre-arranged Market board, TCC counter traded a block of 56,000 shares. On the Normal Board, AFRIPRISE counter had 77,076 shares traded at a weighted average price of TZS 300 per share in 136 deals. CRDB counter had 421,273 shares traded at a weighted average price of TZS 790 per share in 541 deals. DCB counter had 20,665 shares traded at a weighted average price of TZS 130 per share in 80 deals. DSE counter had 2,961 shares traded at a weighted average price of TZS 3,480 per share in 47 deals. MBP counter had 1,219 shares traded at a weighted average price of TZS 450 per share in 10 deals. MCB counter had 110 shares traded at a weighted average price of TZS 290 per share in 2 deals. MUCOBA counter had 50 shares traded at a weighted average price of TZS 400 per share in 1 deal. NICO counter had 2,940 shares traded at a weighted average price of TZS 810 per share in 30 deals. On the Government Bonds Board, a 5-year bond with a coupon rate of 13.00% and a face value of TZS 0.02 Bln was traded at a price of 102.3999% in 1 deal, a 15-year bond with a coupon rate of 13.50% and a face value of TZS 3.00 Bln was traded at prices of 109.4142% and 111.4690% in 2 deals, a 20-year bond with a coupon rate of 15.25% and a face value of TZS 0.88 Bln was traded at a price of 107.7978% in 1 deal, a 20-year bond with a coupon rate of 15.49% and a face value of TZS 1.19 Bln was traded at prices of 100.0000%, 100.5215%, 102.5000%, 104.9216%, 106.8338%, 108.0000%, 108.2500%, 110.0001% and 110.8047% in 10 deals, while a 25-year bond with a coupon rate of 15.75% and a face value of TZS 0.17 Bln was traded at prices of 100.0000%, 108.0153%, 109.0000% and 112.2623% in 5 deals. Also, a 25-year bond with a coupon rate of 15.95% and a face value of TZS 0.27 Bln was traded at prices of 100.0000%, 109.5510%, and 110.3320% in 4 deals.

On the Corporate Bonds Board, a 3-year bond with a coupon rate of 9.50% and a face value of TZS 24.00 Mln was traded at a price of 90.0000% in 1 deal, while a 5-year bond with a coupon rate of 12.00% and a face value of TZS 1.50 Mln was traded at a price 100.0000% in 2 deals.
