### Market Report for Friday, 30 May 2025

DSE recorded a total turnover of TZS 571.00 Mln from 862,827 shares traded in 743 deals, and TZS 16.67 Billion from bonds traded in 13 deals.

On the Block Trade Pre-arranged Market board, VODA counter traded a block of 506,727 shares. On the Normal Board, AFRIPRISE counter had 51,178 shares traded at a weighted average price of TZS 310 per share in 103 deals. CRDB counter had 265,436 shares traded at a weighted average price of TZS 790 per share in 380 deals. DCB counter had 12,321 shares traded at a weighted average price of TZS 135 per share in 45 deals. DSE counter had 2,214 shares traded at a weighted average price of TZS 3,240 per share in 37 deals. MBP counter had 2,405 shares traded at a weighted average price of TZS 455 per share in 13 deals. MCB counter had 390 shares traded at a weighted average price of TZS 285 per share in 2 deals. On the Government Bonds Board, a 5-year bond with a coupon rate of 13.00% and a face value of TZS 13.90 Bln was traded at a price of 104.0004% in 1 deal, a 10-year bond with a coupon rate of 14.00% and a face value of TZS 0.66 Bln was traded at a price of 100.0001% in 1 deal, a 15-year bond with a coupon rate of 13.50% and a face value of TZS 4.00 Bln was traded at a price of 112.2528% in 1 deal, a 20-year bond with a coupon rate of 15.49% and a face value of TZS 2.26 Bln was traded at prices of 100.0000%, 105.0924%, 105.2268%, 105.7770%, 106.8338%, 108.7382% and 110.8047% in 8 deals, a 25-year bond with a coupon rate of 15.75% and a face value of TZS 0.02 Bln was traded at a price of 108.0000% in 1 deal, while a 25-year bond with a coupon rate of 15.95% and a face value of TZS 0.02 Bln was traded at a price of 103.0000% in 1 deal.

On the Corporate Bonds Board, a 5-year bond with a coupon rate of 10.25% and a face value of TZS 100.00 Mln was traded at a price of 84.0000% in 1 deal, while a 5-year bond with a coupon rate of 12.00% and a face value of TZS 141.50 Mln was traded at prices of 99.5000% and 100.0000% in 5 deals.
